



## CONFLICT MINERALS DECLARATION


Subject: Conflict Minerals Declaration in regard to the Dodd-Frank Wall Street Reform and Consumer Protection Act, Section 1502

The Dodd-Frank Wall Street Reform and Consumer Protection Act was signed into U.S. federal law on July 21, 2010. Section 1502 of the Act defines the reporting obligations for companies that are publicly traded in the US and are governed by the Securities and Exchange Commission (SEC). Section 1502 requires companies that manufacture products for which 3TG minerals (Tantalum, Tin, Tungsten and Gold) are necessary to the functionality or production of those products to assess their supply chains and publicly report upon the source of these minerals if they are sourced from the Democratic Republic of the Congo (DRC) or adjoining countries or if the minerals are from recycled or scrap sources.

As a socially responsible, global supplier of electronic and electrical cabling components, we at Inside Track Cabling (ITC) are acutely aware of our civic and societal obligations. Although Inside Track Cabling is not a publicly traded company and therefore is not directly subject to this law, we provide this declaration to our downstream customers to assist them in complying with any obligations that they may have relative to the law. The ITC Conflict Minerals Program has been implemented with guidance obtained from the Final Rules of the Dodd-Frank Wall Street Reform and Consumer Protection Act.

In an effort to complete a Reasonable Country of Origin Inquiry (RCOI), we at Inside Track Cabling Corp. have surveyed our supply chain using the Conflict Minerals Reporting Template (CMRT) created by the Electronics Industry Citizens Coalition® (EICC) and the Global e-Sustainability Initiative (GeSI). This template provides a common means for the collection of sourcing information to aid in the determination of the origin of conflict minerals (e.g. DRC, Covered Countries, Recycler or Scrap Suppliers). This inquiry was reasonably designed and conducted in good faith as an effort to obtain reliable representations indicating smelter or refiner facilities at which conflict minerals may have been processed and to ensure that those conflict minerals did not originate in the DRC, it's adjoining countries, recyclers or scrap suppliers.

Inside Track Cabling does not directly source or process conflict minerals however; 3TG minerals may be contained in our products in the form of solder, or as a component in certain metal alloys. This document declares that certain ITC products may contain 3TG minerals and if so, that these minerals are necessary to the functionality of the products manufacture. Based upon the responses received from our suppliers in regard to the RCOI survey that we have conducted, this document declares that no 3TG minerals contained within our products originate from the DRC or adjoining countries and that all ITC products are declared "DRC Conflict Free".
